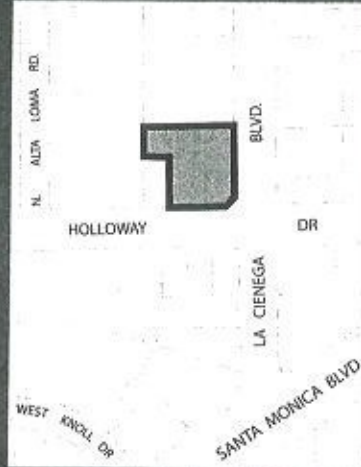


Appeal of the Planning Commission's approval to demolish the existing Chevron station and construct a multi-tenant building, located at 1107 N. La Cienega Boulevard, West Hollywood

WHAT IS THIS?

This notice is to let you know that the West Hollywood City Council will hear an Appeal of the Planning Commission's decision to demolish the existing Chevron building, and construct 2,584 square-foot multi-tenant building for a 24-hour convenience store with off-site sale of beer and wine incidental to the continued use of the service station, a separate retail tenant space, and an attached car wash.

This project has been determined to be exempt from the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15332 (In-Fill Development Projects)

To the Honorable Mayor and Councilmembers:

I am honored to appear before you as legal counsel to the Applicant in this matter for many years, Mr. Ben Pouldar. Mr. Pouldar and his family have operated this business at this site in West Hollywood in an exemplary manner for many years. They also own and operate similar sites in other communities throughout southern California. In every location, including West Hollywood, they have at all times been a valued and contributing member of the community. The Pouldar family is honored to do business in West Hollywood and looks forward to providing the community a new vibrant and beautiful site and services for this long-established business.

This matter comes before you now as an appeal of a unanimous approval by both your Planning Commission and Design Review Committee. This project has also been thoroughly and carefully analyzed and vetted over 3 years, since 2017, by your professional Planning Staff; and, with many compromises by Mr. Pouldar to be responsive to the needs and requests by the City and this community. As a result, now as it did at the Planning Commission, this application comes to this Council with a Staff recommendation of approval.

ACTUAL REASON FOR APPEAL IS TO TRY TO PREVENT THE CLOSING OF AN ECONOMICALLY UNVIALE SERVICE GARAGE, NOT TRULY AN OPPOSITION TO THIS LAND USE PROJECT:

The overriding reason for the appeal addresses none of the salient issues for a land use determination of this sort. Rather, it is brought by some members of the community who are hoping simply to maintain the service garage for the maintenance of their cars.

Unfortunately, keeping the service garage is simply not economically viable. Vehicles do not require the level or frequency of service as they did previously and due to a massive decrease in demand over the years, the income from the service garage has plummeted to levels that simply cannot support its continued operation.¹

The appellant, however, has somehow arrived at the erroneous impression, and related as such to the Planning Commission and may state it again to this Council, that the service garage enjoys an income of \$80,000 per month. That is an incorrect and unfounded statement that was, rightly, also rejected by the Planning Commission as completely irrelevant to the issue of approval or disapproval of this land use application. As confirmed by Mr. Pouldar's CPA in the attached letter, the service garage does *not* have a monthly gross income of \$80,000, but rather has an average gross income of just \$36,583 per month, *all of which* goes to pay operating expenses, mortgage payments and utilities, thus completely eliminating all of its net income. This is the reason that the service garage unfortunately must go and be replaced by another community service, appropriate by land use standards, a car wash along with a new structure for the market and gasoline sales, as well as an independent retail business of some other kind.

COMMUNITY SUPPORT FOR PROJECT:

Fortunately, there is also community support for Mr. Pouldar's project. During the analysis and vetting by Planning Staff there was a Community Meeting for community stakeholders which reflected support, there were several Design Review Committee public meetings (noticed for and attended by the community); and, in preparation for the Planning Commission hearing, as well as in preparation for this hearing on appeal, there has been a great showing of community support.

In that regard, attached please find letters and Petitions by over 300 people in Support of the addition of a car wash, the gas station and convenience market to be remodeled, and for the sale of beer and wine for off-site consumption. 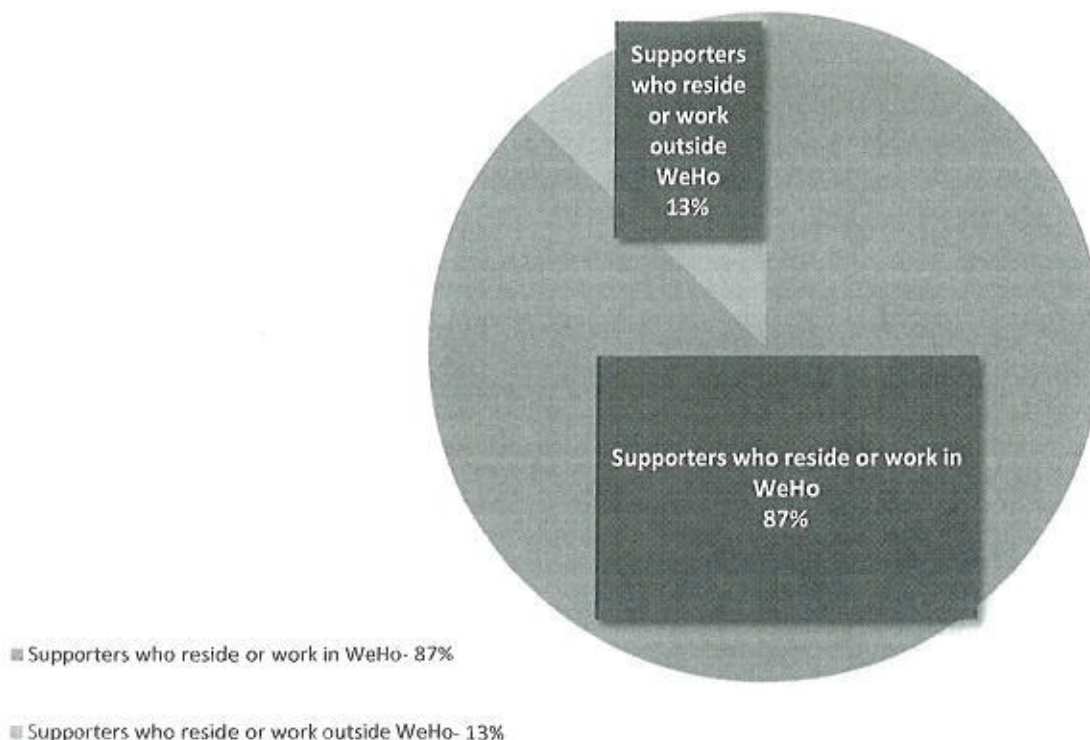

NO ADVERSE IMPACT FROM NOISE BY REPLACING AN EXISTING RETAIL ACTIVITY WITH OTHER RETAIL ACTIVITIES:

Please note as well that a sound study was performed. It reflects that noise produced by the car wash to be mitigated to a negligible level. The Sound Study was submitted to the City. It explicitly determines that there will be no perceptible increase in sound level as a result of this project. Indeed, the Planning Commission imposed Conditions to ensure that to be the case. As indicated by Staff, the vacuum stanchions will not create any noise. The motor that produces the suction and thus the noise associated with a vacuum, is located within a masonry building. The car wash and all activities are thus installed and located on the site in such a way as to minimize the impact of any noise.

Moreover, as the Council is aware, La Cienega and Holloway is a vibrant intersection with an ambient sound level that will not be exceeded by the alteration in retail activities from what has existed at this commercially zoned site for many years.

Planning Staff has reviewed the Report and agrees with its conclusion.

TRAFFIC CIRCULATION NOT ADVERSELY IMPACTED BY REPLACING AN EXISTING RETAIL ACTIVITY WITH OTHER RETAIL ACTIVITIES:

Traffic circulation and parking will not be adversely impacted by the replacement of retail business activities as proposed here. The gas station and convenience store have always been present. The replacement of the service garage with this car wash and change in format of the convenience store will not adversely impact the community. The city's traffic engineer determined that no traffic study was required by law since the anticipated traffic for these uses did not meet the required threshold for imposing such a study; Neither the ITE traffic manual nor the city standard anticipates, therefore, any substantial impact to traffic or circulation.

THIS TYPE OF CAR WASH IS GOOD FOR THE ENVIRONMENT

The proposed project (including the addition of an automated car wash) will enhance the built environment in the surrounding neighborhood and will perform a function / provide a service that is beneficial to the community. The new car wash will have the latest automated washing equipment and will recycle approximately 80 percent of the water it uses. Any discharge from the car wash will be directed to the sanitary sewer system, so no soapy water will be expelled into the streets or storm sewer system. This will benefit the community by providing an environmentally friendly means for the residence and businesspeople in the area to wash their car.

ALL REQUIRED WHMC FINDINGS FOR THIS APPLICATION ARE THUS SATISFIED:

As reflected in the Resolution passed by the Planning Commission previously, all Findings for approval of this application that are necessary under the West Hollywood Municipal Code are satisfied by this project. The following summary of “uses” puts this in context.

The existing store/service structure will be removed and a new architecturally significant building will be constructed. The fueling canopy and dispensers will remain in place as they are today. The new building (approximately 2,500 SF) will be split between a neighborhood market and a new tenant space. In addition to the new market structure, a secondary structure is proposed and will be a new car wash. The car wash is proposed to be roughly 900 SF with two separate equipment storage rooms totaling approximately 376 SF. The operation of the proposed car wash will be done by staff members of the service station who will escort the cars through the automated car wash tunnel and deliver them back to the owners once the wash is completed. The vacuums proposed will be stanchions for suction only; the equipment for the vacuums will be within the storage rooms for the car wash and these storage rooms will be fully enclosed. Inside the car wash will be the washing and drying equipment; the drying equipment will be housed in a noise muffling enclosure custom-designed by a noise engineer (as recommended in the noise study being submitted for the car wash). The car wash is also environmentally friendly. The change from vehicle repairs to vehicle washing is a benefit to the community as well in that it will provide a convenient place for residents to have their cars washed that is environmentally friendly (approximately 80% of the water used in this type of car wash is recycled). A new trash enclosure is also proposed for the northwest portion of the site. Also, in that area of the site will be a Propane Tank as requested by the City for the use of city vehicles and the community. Provided on site will also be 2 Electric Vehicle Charging Stations. Additionally, the store will provide a small amount of beer and wine for take away in conjunction with the myriad of other beverage and food and sundries conveniently available to its customers all in one location, thereby reducing the need for the community to visit multiple locations for its needs.

Operational Hours as proposed and as compromised with Staff and the community:

- Gas Station and Market:
24 Hours a day, 365 days a year as it has operated throughout its existence at this site.
- Car Wash, self-contained, recycling water:
7:00 AM to 9:00 PM, seven days a week. Assisted.

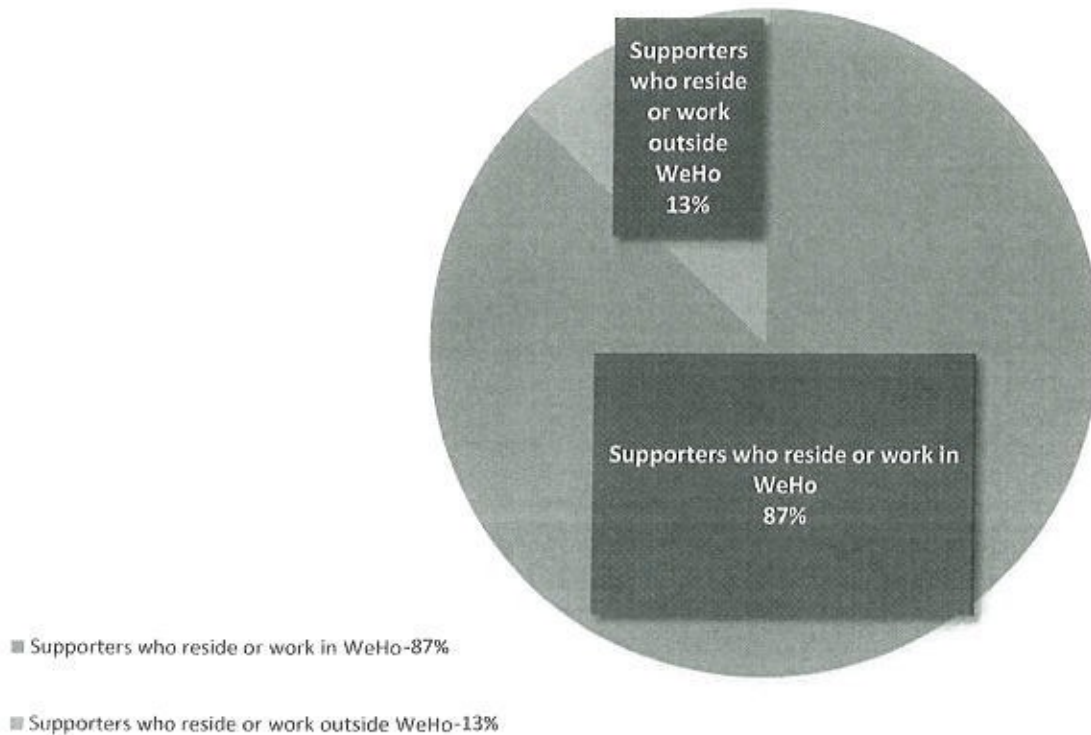
My firm serves as Certified Public Accountants for Ben Pouldar and his related business holdings and assists him in issuing internally prepared financial statements and income tax preparation.
